One of our signature accomplishments was **AIM2SUMMIT**, a large-scale workforce and innovation expo designed to introduce students and families to careers in AI, automation, manufacturing, mechatronics, and skilled trades. Read for the Win

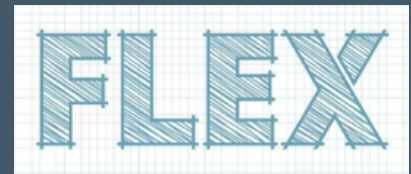
Throughout the year, the Foundation has partnered with strategic literacy initiatives - promoting mentorship, volunteerism, and a love of reading. Led by Ronda Walker, the Foundation’s **Literacy Taskforce** partners with childcare centers, schools, and community events. We have gifted childcare centers with books and appreciation gifts for their dedicated workers. With the help of the Archway Partnership and the University of Georgia, a Birth to Five literacy campaign has been created. With additional funding, we can take these literacy goals to new heights!



Youth Entrepreneurs

In partnership with **Georgia FLEX**, the state's recognized student entrepreneurship initiative, our Foundation was chosen to lead our Laurens County competition. All Laurens County high schools signed letters of intent, opening participation to every 9th–12th grade student. Through FLEX, students attend business-led workshops, develop business plans, receive mentorship from local business owners, and compete in a Shark Tank-style pitch competition with cash prizes—preparing them for ownership, innovation, and leadership.

In March of 2026, our local youth business champion will be selected and will attend the State FLEX Competition in April.
